**NOTICE IS HEREBY GIVEN** that the Proposed Budget of the North Greece Fire District of the Town(s) of Greece and Parma, State of New York, will be presented to the Board of Fire Commissioners of the North Greece Fire District, for its consideration.

A PUBLIC HEARING will be held at 7:00 p.m. at North Greece Fire District Headquarters, 1766 Latta Road, Rochester, New York 14612, in the Town of Greece, State of New York on the 21<sup>st</sup> day of October, 2014. (The Budget hearing must be held annually on the third Tuesday in October.)

Pursuant to Town Law §105, the Board of Fire Commissioners of the North Greece Fire District must hold a public hearing on the budget, make the proposed budget available to the public prior to the public hearing, and allow the public to comment on the budget at the public hearing. The public hearing is held to allow maximum public participation in the hearing.

The purpose of this public hearing is to allow any person to be heard in favor of or against the proposed budget as it is submitted, or for or against any item or items contained in the proposed budget, and hearing all persons interested in the subject concerning the 2015 budget.

A copy of the proposed budget for 2015 is available at the Office of the Town Clerk of the Town of Greece at One Vince Tofany Drive, Rochester, New York 14612, the Town Clerk of the Town of Parma at the Parma Town Hall, 1300 Hilton Parma Corners Rd. Hilton, New York 14468. There is also a copy on file with the North Greece Fire District Secretary at 1766 Latta Road, Rochester, New York 14612, where it may be inspected by any interested person between the hours of 9:00 a.m. to 1:00 p.m., Monday through Friday.

**Please** take notice that the North Greece Fire District of the Town of Greece, County of Monroe, and State of New York shall conduct a meeting of the Board of Fire Commissioners after the aforementioned public budget hearing.
