CERTIFICATE

To the Town Clerk of the Town of Parma, County of Monroe.

This is to certify that the undersigned County Superintendent of Highways will close a section of highway in the *Town of Parma*, County of Monroe, *known as Moul Road, between Bennett Road and Lighthouse Road*.

It is necessary to close that portion of highway effective, *August 3, 2017 at 9:00 AM for approximately 60 days for culvert replacement* under the provisions of the Highway Law, and the work cannot be properly conducted and completed unless the portion described be closed during the time such work is in progress. Please notify your Town's police, schools, fire department, ambulance and post office of this closing.

To the Superintendent of the Town of Parma, County of Monroe.


