To the Town Clerk of the Town of Parma, County of Monroe.

This is to certify that the undersigned County Superintendent of Highways will close a section of highway in the *Town of Parma*, County of Monroe, *known as Burritt Road, between Hill Road and Hilton - Parma Corners Road.*

It is necessary to close that portion of highway effective, November 1, 2018 at 9:00 AM *for approximately 1 month for culvert rehabilitation* under the provisions of the Highway Law, and the work cannot be properly conducted and completed unless the portion described be closed during the time such work is in progress. Please notify your Town's police, schools, fire department, ambulance and post office of this closing.

You are hereby notified that the above described section of highway will be closed by me effective, *November 1, 2018 at 9:00 AM for culvert rehabilitation*, and the traffic will be detoured in the following manner.

DETOUR: Clarkson Parma Townline Road, Parma Center Road, and Hilton – Parma Corners Road (NYS Rte 259).

Notes: The road will remain open to local traffic only up to the culvert.
