**MINUTES OF ELECTION**



By announcement of the Chairperson, the polls were opened promptly at 6:00 p.m. By announcement of the Chairperson, the polls were closed promptly at 9:00 p.m. Thereafter, ballots were canvassed by the Ballot Clerk(s) and Election Inspector and the results of the canvass were announced publicly by the Chairperson as follows:

SHALL the bond resolution of North Greece Fire District, in the Towns of Greece and Parma, New York, entitled: "BOND RESOLUTION OF THE NORTH GREECE FIRE DISTRICT, IN THE TOWNS OF GREECE AND PARMA, MONROE COUNTY, NEW YORK, ADOPTED AUGUST 13, 2024, AUTHORIZING THE ISSUANCE OF BONDS IN A PRINCIPAL AMOUNT NOT TO EXCEED \$13,800,000 TO FINANCE THE CONSTRUCTION OF A NEW FIREHOUSE ON LAND TO BE ACQUIRED BY THE FIRE DISTRICT ON ENGLISH ROAD; STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$13,800,000; APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE; AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF SAID BONDS AND THE INTEREST THEREON AS THE SAME BECOME DUE AND PAYABLE," be approved?
