NOTICE OF PUBLIC HEARING ON BUDGET

WHEREAS the Board of Fire Commissioners, pursuant to Town Law §§ 105 and 181 is required to adopt its proposed fire district budget for calendar year 2025, at least 21 days before October 15, 2024, so that it is available for public inspection prior to the budget hearing, and

WHEREAS the Board of Fire Commissioners of the North Greece Fire District on the 24 day of September 2024, adopted the proposed budget and set the North Greece Fire District Annual Budget Public Hearing for 2025, and

NOW THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners of the North Greece Fire District adopted its proposed Annual Fire District Budget for 2025 on September 24, 2024 for purposes of discussion and review at the Budget Hearing to be held on October 15, 2024 and a copy of the proposed budget is available at the office of the Town Clerk of the Towns of Greece and Parma and on the district website at www.northgreecefd.com and at the office of the North Greece Fire District Secretary at 1766 Latta Road, Rochester, New York, where it may be inspected by any interested person during the office hours of 9 AM to 3 PM. In addition, copies of the proposed budget will be available on the night of the said public hearing, and

BE IT FURTHER RESOLVED that the Board of Fire Commissioners of the North Greece Fire District will hold the Annual Fire District Budget Hearing to be conducted with reference to the North Greece Annual Fire District Budget for fiscal year 2025 on Tuesday October 15, 2024, at 6:00 P.M. or as soon thereafter as the public may be heard, at the North Greece Fire District's Station 2 located at 1766 Latta Road, Rochester, New York.

NOTICE IS HEREBY GIVEN that the aforesaid budget will be presented to the residents and taxpayers of the North Greece Fire District and to the Board of Fire Commissioners of the North Greece Fire District , for their respective consideration at this public hearing and for the purpose of considering the said budget and hearing all persons interested in the subject concerning same. Public comments will be limited to those matters in favor or against the proposed 2025 Budget.
