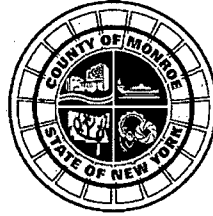

NOTICE OF HEARING

PLEASE TAKE NOTICE that in accordance with Article 25-AA, Section 303-b of the NYS Agriculture and Markets Law, a public hearing will be held by the Planning and Economic Development Committee of the Monroe County Legislature on Monday, July 26, 2021 at 5:45 p.m. at the Legislative Chambers in the County Office Building, 39 West Main Street, Rochester, New York regarding additions to the Monroe County Western Agricultural District #5, located in the Towns of Greece and Parma. The public hearing is being held to give the public an opportunity to comment on: (1) the proposed additions to the District; and (2) the recommendations of the Monroe County Agricultural and Farmland Protection Board.

The existing District occupies a portion of the Town of Greece and Town of Parma. The following parcels are proposed to be added to the District:

Monroe County Western Agricultural District #5:

- 64 Payne Beach Road, Town of Greece (Hilton mailing address), consisting of approximately 45.00 acres, tax account number 017.01-2-1, owned by Ryan A. Perry.
- 1604 Clarkson Parma Town Line Road, Town of Parma, New York, consisting of approximately 42.35 acres, tax account number 055.02-2-6, owned by Brandon Kelley and Elena Kelley.

The Monroe County Agricultural and Farmland Protection Board have reviewed the proposed additions to the District and recommends that the District be modified to include the additional parcels.

Detailed maps of the existing District and proposed additions may be examined in the Office of the Clerk of the Monroe County Legislature, 407 County Office Building, 39 West Main Street, Rochester, New York. A report that includes the recommendation of the Monroe County Agricultural and Farmland Protection Board regarding the proposed additions may also be examined in the Clerk of the Legislature's Office.

All parties of interest and citizens will be heard at the Public Hearing.
